Overview E

Budget:

- The Board's fund reserve remains stable; however, future revenues may not increase at the same rate as departmental service costs. Staff will continue to monitor and to advise the Board.

SB 541 – Expert Consultants

- SB 541 streamlines the process for boards under the Department of Consumer Affairs to contract with subject matter experts to review disciplinary cases, testify at administrative hearings or assist in examination development. The bill is an urgency measure and will take effect immediately upon being signed by the Governor and chaptered by the Secretary of State. It has passed both houses of the Legislature without any "no" votes, and was enrolled for the Governor's signature on September 8. The Board submitted a letter of endorsement to Governor Brown on September 8.

SB 1441 – Uniform Standards Regarding Substance-Abusing Healing Arts Licensees

- The Medical Board has updated its Manual of Disciplinary Guidelines to incorporate components of the DCA Uniform Standards. BPM staff is proposing conforming amendments to its guidelines to maintain consistency (see tab N), and is closely monitoring MBC's progress on its regulatory rulemaking proposal that incorporates these amendments by reference.

Enforcement Data Tracking & Reimbursement Accounting

- With an increase in the number and complexity of financial reports requested by various DCA programs, staff has developed an enforcement accounting database and billing system that allows for point-in-time calculations of cost recovery payments and balances. This new system has streamlined the Board's data reporting and billing processes, and provides a readily verifiable basis for all enforcement receivables.

National Part III Exam

What was previously known as NBPME Parts I, II and III will now be designated as the American Podiatric Medical Licensing Examination (APMLE) Parts I, II and III. The NBPME will still remain as the parent organization that owns and is responsible for scoring of each test series and its production.

The results of the APMLE Part III exam held June 1st, revealed an 89% pass rate for California examinees. This pass rate is calculated at California's passing score of one standard measurement of error above the National APMLE passing score, pursuant to B&P code section 2493 (b), which is proposed for Sunsetting in the staff draft of the BPM Sunset Report. The next part III exam is scheduled for December 7, 2011.

Continuing Competence and CME Audit

Staff is currently in the process of conducting an annual audit for licensee Continuing Competence and CME requirements. The randomly selected 20 licensees (one percent) have a scheduled renewal date of December 31, 2011 and must submit documentation by December 1, 2011.

ANNUAL AGREEMENT

PROVIDING PODIATRIC MEDICAL CONSULTANT SERVICES TO THE BOARD OF PODIATRIC MEDICINE

I agree to provide podiatric medical consulting services to the Board of Podiatric Medicine pursuant to the general direction and supervision of the executive officer and/or his designee(s), e.g., the board's enforcement coordinator. I will assist in investigating and evaluating the complaints of professional misconduct against licensees, interpreting the medical significance of information and evidence. Specific tasks will include:

- Review complaints on Doctors of Podiatric Medicine (DPM) to evaluate the need for additional information or referral for formal investigation.
- Review medical records and other documents obtained by the board's consumer services analyst (CSA) to evaluate the medical care provided the patient.
- Assist investigators and Deputy Attorneys General in evaluating completed investigations to ensure quality and completeness.
- Assist the CSA in answering complaints from consumers, peer organizations and other sources regarding medically related matters.
- Personally obtain information and evidence that requires the immediate knowledge of podiatric medicine to secure.
- Assist in monitoring probationers as requested.
- Conduct educational/physician interviews with licensees as necessary.
- Assist in the training of expert reviewers and witnesses.
- Serve as a witness at hearing, as necessary.
- Other duties as requested.

The executive officer and/or his designee(s) will assign cases.

Payment for services rendered shall be at the rate of \$75.00 per hour to be paid in arrears following submission of a Statement of Services subject to the approval of the Executive Officer (see attached). Expenses (postage, telephone, etc.) shall be reimbursed. Travel expenses shall be reimbursed at the rates established for non-represented state employees.

Either party may terminate this contract by the giving of thirty (30) days written notice of termination to the other party. In the event this contract is terminated, consultant agrees to return to the State any and all materials related to this contract, and consultant shall be paid for services rendered and expenses incurred up to the date of termination. Consultant also agrees to return to the State, immediately upon request of the Executive Officer and/or his designee(s), any and all materials related to this contract (files, correspondence, uncompleted or completed reports, notes, records, etc.) at any time during the term of the contract.

Consultant agrees to hold all confidential matters confidential.

Consultant agrees to abide by the board's conflict of interest policy (attached).

Consultant agrees to attend training, as necessary, and review the current and all updates of the BPM Enforcement Manual.

POLICY DECISION: Minimum Requirements for New Medical Consultants, Experts, and Examiners

1. Hold a current, valid and unrestricted California license to practice podiatric medicine.
2. Be active in the practice of podiatric medicine in the subject area being reviewed.
3. Have completed a postgraduate medical education program approved by the Council on Podiatric Medical Education.
4. Be certified by the American Board of Podiatric Surgery and must maintain a current certificate.
5. Have surgical staff privileges in at least one general acute care hospital facility.
6. Must not have been subject to disciplinary action by the BPM, i.e., the filing of an Accusation or Statement of Issues that was not withdrawn or dismissed.
7. Must not be under BPM investigation for a violation of any laws relating to the practice of medicine at the time of appointment or be the subject of such a case pending in the Attorney General's office.
8. Must not have been the subject of a field investigation by the BPM within the last five (5) years that was not closed and deleted from Medical Board records.
9. In the event of a conflict of interest, must recuse themselves from the review or examination.
10. Must not misrepresent his or her credentials, qualifications, experience or background.

POLICY DECISION: Selection, Training and Evaluation of Board of Podiatric Medicine (BPM) Medical Consultants

1. Potential DPM Medical Consultants shall be reviewed and nominated to the Consultant pool by the Board's Enforcement Committee.
2. New candidates must be approved by unanimous vote of the Board Members present at a noticed public meeting.
3. Following approval by the Board, Consultants shall certify in writing prior to beginning work that they have received and read the current *BPM Enforcement Manual*.
4. Likewise, all consultants shall so certify receipt and reading of each revision to the *BPM Enforcement Manual*.
5. Consultants shall be evaluated at least on an annual basis.
6. Staff shall organize training sessions for consultants every two years as practicable, and each working consultant must have participated in a BPM training session before beginning work and within the past four years at all times.
7. Consultants may serve for eight consecutive years, and have at least a two-year break in service before being eligible for re-nomination by the Enforcement Committee.
